



Softlogic Money Market Fund

Investments: Fixed Income Securities

Softlogic Money Market Fund is an open-ended money market fund incorporated in Sri Lanka, investing in short term LKR based corporate debt instruments including commercial paper, securitized paper, bank deposits as well as Sri Lanka Treasury Bills, Bonds and government securities backed Repurchase transactions. The Fund aims to provide liquidity to investors while enhancing returns by investing in a diversified portfolio of short-term debt securities with maturities less than 365 days.







FUND MANAGER CORNER

By end of June, the fund yielded a return of 9.47% compared to NDB CRSIL index return of 5.50%. The Central Bank of Sri Lanka maintained the Standard Deposit Facility Rate (SDFR) and Standard Lending Facility Rate (SLFR) at 8.50% and 9.50% respectively. The Government securities rate went up slightly due to offered amount from the Central Bank being higher than the maturities to build a buffer , with T Bill weighted average rates for tenors of 3, 6, and 12 months going up to 10.07%, 10.19%, and 10.31% respectively at the auction held on 26th June 2024 with a 145-basis point increase compared to May 2024 in the 3 months T-bill. Looking ahead, it is anticipated that Government securities rates will slightly come down to the end May levels in the short term.
